RESOLUTION NO. 15-10-14-470

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF
KING COUNTY WATER DISTRICT NO. 125, KING COUNTY,
WASHINGTON, REVISING WATER METER INSTALLATION
AND METER DROP CHARGES.**

WHEREAS, King County Water District No. 125 ("District") charges property owners seeking to connect real property to the District's water system a water meter installation charge to recover the cost of materials, paving, labor, equipment, permitting and administration incurred to process such requests and install such water service lines and meters ("Water Meter Installation Charge"); and

WHEREAS, the District also charges property owners seeking to connect real property to the District's water system where the property owner has installed the water service line and meter box a charge to "drop" in a water meter and angle stop to provide District water service to the real property ("Meter Drop Charge"); and

WHEREAS, the District has charged the owners of real property located within the City of Tukwila ("Tukwila") water meter installation charges that are higher than other jurisdictions such as the Cities of Seatac and Burien, and in King County due to Tukwila's imposition of a pavement mitigation fee ("Mitigation Fee") for water service installations; and

WHEREAS, District staff and the District's consulting engineers have recommended the District increase its water service installation and meter drop fees and charges to fully recover the cost of such services; and

WHEREAS, the District is authorized to recover such water service installation and meter drop fees and charges pursuant to Chapter 57.08 RCW; now, therefore,

BE IT RESOLVED by the Board of Commissioners of the King County Water District No. 125, King County, Washington, as follows:

1. Water Meter Installation Charges:

The following water meter installation charges shall be paid to the District by parties seeking to connect real property to the District's water system based on customer meter size and jurisdiction in which the meter is installed as follows:

A. New Water Service Installations in the City of Tukwila

5/8"x 3/4" \$3,750 (including \$750 mitigation fee)
1" \$4,250 (including \$750 mitigation fee)

B. New Water Service Installations in the City of SeaTac and Burien and in Unincorporated King County:

5/8"x 3/4" \$3,000
1" \$3,500

C. Meters Larger than One (1) Inch Located in any Jurisdiction:

The charge for the installation of water meters larger than one (1) inch for real property located in the City of Tukwila shall be determined on a case-by-case basis based on the actual installation costs, permitting and other fees and costs incurred by the District plus fifteen percent (15%) overhead.

2. Meter Drop Charges in any Jurisdiction.


A Meter Drop Charge of Six Hundred Dollars (\$600.00) shall be paid to the District by parties with real property where the party has installed the water service line and meter box as required by the District, to "drop" in a water meter and angle stop to provide District water service to the real property.


3. Effective Date: The revised water meter installation charges set forth in this resolution shall be effective and imposed as of October 14, 2015.


4. Amendment: District Resolution No. 12-09-26-450 and all other District resolutions, policies and procedures are hereby modified, amended and superseded to be in accordance with the provisions of this resolution.
