
A RESOLUTION approving an extension

(LARRY'S MARKET)


BE IT RESOLVED by the Board of Water Commissioners of Water District No. 125, King County, that the application, and plans and specifications, for an extension to the Water District's System, as hereinafter described, be and it is hereby approved subject to compliance with the District's standards and procedures for developer extensions.

BE IT FURTHER RESOLVED that the extension hereinafter described is an addition and betterment to the water system of the District, and the Comprehensive Plan be and it is hereby amended accordingly.

Extension Description: 464 lineal feet 10" DI pipe, 2 eight inch connections and detector check assemblies, onsite hydrant, two offsite hydrants, and service meter.
